

PRIVACY POLICY

Basic Premise

This Privacy Policy ("Privacy Policy" or "Policy") describes information about the categories of personal information collected by SUTAA ASSIST and its affiliates ("we," "us," "our," or "SUTAA ASSIST") through your voluntary access to the platform or www.sutaaassist.com ("Site") or obtained in connection with any services provided by us, why we collect it, and the types of entities to whom we may disclose your personal information. We also describe rights you may have with respect to such information. When you access our platform and/or utilizing any of our Services, as defined below, you agree to our collection and use of personal information as described in this Policy and our Terms of Service, and any other agreements, disclosures, operating rules, policies and procedures that may be, from time-to-time, required by us, delivered to you, or published on the Platform by us, each of which is incorporated by reference and each of which we may update from time to time without notice to you.

Scope of information acquired

By accessing our platform, we automatically collect and store internet domain names, IP addresses, Computer connection information. Through our contact forms we may collect personal informations such as Name, e-mail address, Mobile Identification Number. Our platform will also serve as a landing page for social media platforms and may automatically collect personal information that you publicly made available on those media platform.

Purpose of Use

We collect those personal and non-personal information for the following purposes:

- (1) To provide and Operate the services we provide, analyze and improve your experience on our Site;
- (2) Maintain regular communications with you regarding our services;
- (3) We also allow third parties (including Google and Meta) to use third-party cookies, web beacons, and other storage technologies to collect or receive information about how you interact with our Site and elsewhere on the Internet and use that information to provide analytics and other measurements services, to improve our respective services, and to deliver and target advertisements tailored to you.
- (4) To comply with applicable laws and regulations.

Management of Collected information/s

We strive to ensure, improve and correct security protocols in order to prevent unauthorized access, loss, destruction, falsification, and leakage of personal information, and manage personal information safely. Our website is SSL-compatible in order to protect your personal information. Those measures include administrative, physical, and technical safeguards to protect the security, confidentiality, and integrity of personal information. However, data security incidents and breaches can occur due to a variety of factors that cannot reasonably be prevented; therefore, our safeguards may not always be adequate to prevent all breaches of security.

Provision to a Third Party

As a general policy of the site, we will not provide personal information to third parties without the prior consent of the user, except when authorized by the Personal Information Protection Law and other laws and regulations within the jurisdiction of Japan.
